Trafford Borough Officials,

The following is a brief summary of Trafford Fire Departments activities for January 2021. Projected activity for next month, Public Safety concerns, and other information you should be aware of is also included.

Fire Department: Responded to $\underline{14}$ alarms; attached you will find a complete breakdown of the incidents and activity for this period included with this letter.

EMS Division: Provided <u>156</u> Non-Emergency Medical Transports throughout the greater Pittsburgh area. The proceeds from these transports are used to support the Fire, Medical, and other essential services we provide to Trafford; this is your Fire Department's PRIMARY source of income.

Training: Members participated or completed training last month for the following:

- International Association of Fire Chiefs symposium for Volunteer Chief Officers
- Civil Unrest Related Emergencies presented by the National Fire Academy
- Drill; "Legacy vs Modern" construction, fire behavior, and suppression tactics review

Fundraising:

No Fund Raising scheduled other than the Medical Transport Division.

General:

- Grant Application submitted to PA Office of the State Fire Commissioner for firefighting equipment and vehicle warning devices (copy provided)
- Grant Application submitted to FEMA for new pumper
- Letter expressing concerns regarding the proposed amusement tax (copy provided)
- Letter of explanation regarding the Sewage Bill for 401 Brinton Ave (copy provided)
- Fire Dept Crews continue to respond to Medical Emergencies using PA Department of Health and UPMC established COVID-19 precautions and guidelines.
- All Non-emergency events are postponed until further notice.

Next month(s)

 The Coronavirus will obviously impact Fire/EMS Operations for the next several months. We have purchased sufficient N95 masks and personal protective equipment for the next several months.

Fire & Life Safety Concerns:

- For more than a year, I have reported to Council and the Mayor that vacant or dangerous structures continue to present a hazard to neighboring properties and the general public. Fighting Fires is inherently dangerous in any structure. These dangers are significantly increased when dealing with structures that have sat vacant for several years and have weakened structural components. I realize that Borough Council is taking action towards mitigating some of these issues; however, I continue to offer to work with Council and Code Enforcement to identify and placard these structures to warn Firefighters and the general public. I am again requesting a meeting with the Borough Council decision makers as soon as possible to expedite this process.
- The fence erected over a year ago (September 2019) on the corner of Third Street & Cavitt Ave
 is still blocking fire department access to the fire hydrant located in front of this structure.
- International Fire Code: The purpose of building and fire codes is to ensure the quality and safety of commercial and residential building structures. These codes set the minimum requirements to safeguard the occupants of a building, and to protect the building structure from various threats and exposures. Trafford has numerous buildings and groups of buildings that are uninspected or under inspected and operate virtually unregulated. Many of the processes and products used are hazardous to life and the environment. The International Fire Code (IFC) and Life Safety Code (NFPA 101) offer guidance and regulations authored by industry experts; if adopted and enforced, these tools can help create a safer workplace and protect our citizen and our environment. The revenue related to the Permits and Processes included with these texts can offset the costs associated with inspections and enforcement. May I remind you that I included several pages with my July 2020 report regarding the Operational Permits available to us should we adopt the International Fire Code. While Trafford does not have every one of these types of activity in progress today... you would be shocked to know just how many of these potentially hazardous processes are already happing in our Borough. The fee's associated with these permits and inspection could generate thousands in revenue for the Borough; however, the increased level of protection and overall safety of our citizens and first responders would be our first priority. I continue to offer my assistance and to present these Codes and Programs to Council as they apply to specific hazards in several occupancies in Trafford TODAY, and urge we move swiftly to mitigate some of these hazards.

COVID-19 Situation Report (SITREP) for: January 2021

The COVID-19 "State of Emergency" is likely to continue throughout 2021. The anticipated "operations tempo" is considered <u>manageable</u> for our current level of staffing and funding.

We have identified our long range Personal Protective Equipment (PPE) requirements for the department and we continue to work with FEMA, PEMA, and other sources to acquire these items.

Personnel Status:

One Firefighter was confirmed positive for Covid-19 in December; He/she was quarantined at home; symptoms were not life threatening, and he/she has since fully recovered. 9 other members of his/her family were also confirmed positive, the ill effects varied from minor to serious; however, none of the family members required hospitalization. We are happy to report that ALL have recovered.

VACCINE: 5 of 8 Emergency Medical Service Providers have already completed the vaccination process (2 rounds) with only minor side effects (general malaise, headache, soreness at the injection site).

Trafford's participation in the "Mass Vaccination process for the general public" is yet to be determined.

The Department still has 2 bunkrooms with 4 Beds prepared and ready in the Fire Station Residence for staff quarantine; we also have the ability to flex up to 7 beds with the use of cots if needed: None of these beds are in use at this time.

COVID-19 Exclusion Area status continues for all Fire Department areas of the first and third
floors – the "NO VISITOR" policy remains in effect. Advance notice is requested should Public
Works require access to these areas. DPW personnel should be made aware that the
personnel working inside these areas may have been exposed to the corona virus – contact
tracing is required by PADOH. We also need to sanitize after DPW departs, as we cannot
confirm their status prior to their visit.

Operations:

EMS Units transported 156 patients in January, 11 of these patients were confirmed to be Positive for COVID-19 prior to transport.

2 Ambulances are in service (primarily in use for UPMC Transports) — Both ambulances are available to surge into local emergency use if requested by Penn Township EMS — No flex to emergency service is expected in next operational period (February 2021).

1 Advanced Life Support Quick Response Unit (ASL-QRS) is in service and available **24/7 for 911 Dispatch Emergencies**. This unit routinely responds to serious medical emergencies and vehicle accidents in support of Penn Township EMS Transport Units.

3 other Fire Department Vehicles are in service and available.



B. Repair of firefighting, ambulance, or rescue equipment OR purchase thereof.

Grant Funds Expended: \$13580.00

Problem(s) And/Or Need(s):

Description of Project: This portion of our Grant Application is for Rope Rescue related tools and equipment, forcible entry tools, and emergency vehicle warning devices. We are asking for grant funds to purchase: Hydra-Ram forcible entry tool for accessing metal and reinforced residential and commercial doors. Emergency vehicle warning lights and communication system for use on the fire department ALS squad. Life Saving Ropes, Harnesses, devices, and other tools related to Rope and High Angle Rescue.

Benefits to be Realized: 100% of our current rope rescue equipment is out of compliance and is no longer in service for "life safety or rescue duties". The rope rescue tools and related items listed will enable us to deploy our personnel in fully compliant rescue gear should a rope rescue situation occur. This equipment will be stored in a "ready" condition on our engine and attack vehicles and is available for our department and those departments and agencies that respond as mutual aid. The Hydra-Ram will replace the departments 22 year old ram which failed during a recent medical emergency; repair parts for this model are no longer available. We use this tool regularly during medical emergencies in our 10 story residential building. The vehicle warning devices will enable this vehicle to meet or exceed NFPA Standards along with federal, state, and local requirements for vehicle warning lights, which enhance responder safety while operating on an emergency scene.

Trafford Borough Officials,

I am writing you today in regards to the proposed Amusement Tax Ordinance, and to bring to your attention to the potential impact this Ordinance could have on your Volunteer Emergency and other Essential Community Services. Though we do not have figures of how the proposed ordinance will affect Fraternal Order of Police, Public Library, or Food Bank Fundraising Events, we can relate to you the specific impact it will have on your Fire Department.

We usually conduct two specific types of fundraisers that support our ability to deliver emergency and non-emergency essential services to the Borough of Trafford, they are selling hoagies and our 200 Club Dinner. Though the Covid-19 Pandemic has quelled any attempt to conduct in person fundraisers recently, in years past these events generated \$6,000 to \$8,000 in Net Profits.

Our average hoagie sale of 30 dozen hoagies would net \$2,160 (30 dozen sold at \$6 each); however, after expenses, we would net approximately \$810 (\$2.25 each). It takes about 6 hours for our volunteers', our families, and friends of the department to make the hoagies, and around 6 hours to sell them all (approximately 12-16 people = 168 man-hours avg.). With the proposed 10% tax on "Gross" proceeds, the new tax would cost the Department \$216.00 or 26.6% of the net profit, leaving just \$594 towards operating costs.

The annual 200 Club Dinner is significantly more labor intensive. Preparations start 4-5 months in advance, with multiple planning & progress meetings, soliciting of donations for the auctions and sponsors for door prizes, preparing and selling the tickets, arranging the catering and beverage service... the list goes on and on. Though I've never counted every single man-hour... we can easily account for over 500 without difficulty. The evening event generated nearly \$10,000 worth of gross receipts in November 2019 (this was our best year ever); however, after paying for the cash prizes, catering, beverages, room rental, and other expenses, our Net Profit was approximately \$4,000. The proposed ordinance would Tax the Department \$1,000, taking 25% of the net profit.

When you read "10% Tax on Amusement Events", it may seem like a small insignificant amount of money. We are hopeful you will realize just how significant this proposed Ordinance as written is, and the financial impact it could have on those non-profits that provide essential services to our town.

We propose an exemption for "those non-profits that specifically perform an essential service on behalf of Trafford Borough". We are confident the taxes lost by exempting the Police, Fire, and EMS Departments, along with the Library and Food Bank would be more than offset by the essential services they provide to the citizens of Trafford.

We appreciate your consideration.

Trafford Borough Sewage Department Re: 401 Brinton Ave – Sewage Billing

Dear Trafford Officials,

Please find the enclosed payment in the amount of \$1,671.88; this amount includes \$351.06 listed as a "previous balance" from the previous owner, and approximately \$247.41 in late fees and penalties.

A brief history of this building and how the Fire Department came to own this property; this building and associated businesses were owned by Mr. John F. Walko Jr. up until December of 2017. It was at this time the Fire Department entered into an agreement to purchase the property and the building. The business itself was closed due to a significant fire on May 21st, 2005. Though Mr. Walko did repair the structural damage after the fire, the business remained closed and the building has sat vacant since the fire. It is our desire to rehabilitate this building and return it to a safe and habitable condition, and eventually a revenue producing occupancy that financially supports the volunteer fire departments operations. According the Mr. Walko, the water has been shut off and the water meter removed for several years. The bills we have received indicate the last payment on this property was in July of 2014. When we purchased this property in December of 2017, there was no water service, no water meter, and no account open with Wilkinsburg Penn Joint Water Authority. We have not initiated Water Service for this property.

Please correct the <u>service</u> address to reflect: **401 Brinton Ave** (see enclosed tax map information). Please also change the <u>billing</u> address to: Trafford Fire Co. No. 1 at **PO Box 86** – Trafford PA 15085. The Sewage Bills currently indicate 401 Westmoreland Road (the post office does not deliver to the fire station, and we do not receive mail at the 401 Brinton Ave location).

Due to the Covid-19 pandemic, our ability to conduct fundraising events has been significantly impacted, as I'm sure you are intimately aware. Every dollar counts; we appreciate any consideration regarding the previous balance and current penalties.

I am hopeful this letter resolves any confusion or conflict in this matter.
